1. No purchase necessary.

4. Limit of one receipt or photo log per day, per user. The same receipt or photo cannot be logged on multiple entries and email addresses.
5. To view the qualified Brookfield Properties or Brookfield Place food vendors select the property you visited and use the "Restaurant" filter to view the list of qualified food vendors.
