# Shower Facility Agreement (the "Agreement")

BROOKFIELD PLACE (CALGARY)LP, by its sole general partner BROOKFIELD PLACE (Calgary) GP Inc. (the "Owner") agree to provide the User access to, and use, of the shower facilities (the "Shower Facilities") on the P1 parkade level of the east tower of Brookfield Place located at 225 – 6<sup>th</sup> Avenue S.W, Calgary, Alberta (the "Building") subject to the following terms and conditions:

- 1. The Shower Facilities are reserved for the exclusive use of the employees of the tenants and subtenants of the Building; and
- 2. An access card, issued by the Owner or Building manager, is required to enter the Shower Facilities. Only persons specifically authorized by the Owner or Building manager following execution of a valid Agreement and after provision of an access card may use the Shower Facilities.
- 3. The use of the access card by any person other than the User will result in the immediate termination of this Agreement; and
- 4. The Owner reserve the right, without notice, to revoke the User's access to the Shower Facilities and terminate this Agreement if the User breaches any of the terms and conditions herein; and
- 5. On the expiry or earlier termination of this Agreement, the Owner shall de-activate the access card and the User will no longer have access to the Shower Facilities; and
- 6. Any and all expenditures that the Owner may incur due to damage of the Shower Facilities caused by the User shall be borne entirely by the User; and
- 7. All rights and covenants herein are personal to the User and, the User may not assign or transfer this Agreement nor allow any access to the Shower Facilities to any other person; and
- 8. The User acknowledges that the Owner may, without compensation to the User, close all or part of the Shower Facilities or Building or any portion thereof, at any time and from time to time in the Owner sole discretion for any reason, including without limitation, for cleaning, repairs, maintenance or any safety or security reasons; and
- 9. The Owner may terminate this Agreement at any time for any reason upon notice to the User; and
- 10. The User may terminate this Agreement at any time upon notice to the Building manager

# <u>TERM</u>

The term of this agreement shall commence on the Commencement Date and shall expire on the earlier of: (a) the expiration or earlier termination of the Tenant's lease in the Building, or (b) the date this Agreement is terminated by the Owner or the User in accordance with the terms and conditions herein.

# RULES AND REGULATIONS

The User shall strictly comply with the rules and regulations enacted from time to time by the Owner and communicated to the User, which are intended to ensure operational efficiency, cleanliness and security of the Shower Facilities. A copy of the Rules and Regulations as of the date of this Agreement is attached hereto as Schedule "A".

### LIMITATION OF LIABILITY

In consideration of the Owner providing the User with access to, and use of, the Shower Facilities, the User agrees the Owner, the Owner's related entities, the management company for Building and any other party with an interest in the Building and the respective affiliates, directors, officers, employees, agents, contractors, heirs, executors, administrators, legal representatives and assigns for each of the foregoing (collectively, the "Released Persons") shall not be liable for, or in any way responsible to, the User and his or her heirs, executors, administrators and assigns, and the Released Persons are hereby unconditionally released in respect of: (a) any theft, damage to or destruction or loss of any property of the User; or (b) any bodily injury (including death), personal injury, damages for personal discomfort or illness or consequential, incidental or indirect injury or damage of any kind sustained by the User; or (c) loss, injury or damages (including, consequential loss) sustained by the User due to any reason or cause whatsoever including, any loss, injury or damages caused by, arising from, or related to the Shower Facilities and the Building howsoever caused including, whether or not caused in whole or in part by: (d) the negligence, acts or omissions of any or all of the Released Persons; or, (e) any act or omission of any other user, tenant or occupant of space in the Shower Facilities or the Building.

# **INDEMNIFICATION**

The User shall indemnify and save harmless the Released Persons against any and all claims, actions, damages, losses, liabilities, costs and expenses (including, those in connection with bodily injury (including death), personal injury or damage to or loss of property) due to, or arising from, or out of, or related to, or occasioned wholly or in part by: the occupancy or use by the User of the Shower Facilities or any other part of the Building; or, any negligence, act or omission of or by the User or by any person for whom the User is legally responsible. If the Released Persons or any one of them, without fault on its part, be made a party to any litigation commenced by or against the User, then the User shall protect, indemnify and hold the Released Persons harmless in connection with such litigation. The Released Persons, or any one of them, may elect to participate in any litigation or settlement discussions relating to the foregoing, or any other matter for which the User is required to indemnify the Released Persons hereunder. This indemnity shall survive the expiration or earlier termination of this Agreement.

#### REMEDIES

If the User defaults on the terms or conditions contained in this Agreement, the Owner shall be entitled to all remedies provided by law, including without limitation, recovery of damages, collection, costs, legal fees (on a solicitor client basis), and the right to termination set forth herein.

# Schedule "A" Shower Facilities - Rules and Regulations

The following Rules and Regulations have been adopted for the safety, benefit and convenience of all users of the Shower Facilities:

- Each User must possess and use a valid access card to access the Shower Facilities.
- The Shower Facilities are open 24 hours a day, 7 days a week except during periods of cleaning, repairs, maintenance or any safety or security reasons, and during any real or apprehended emergency.
- Only person(s) specifically authorized by the Owner and/or Building manager may access the Shower Facilities.
- The use of the access card by any person other than the User will result in the immediate termination of access to the Shower Facilities.
- Guests and other invitees are not permitted.
- Aggressive or violent behaviour towards staff or any other user of the Shower Facilities will not be tolerated under any circumstances.
- Each User shall turn off the water in the sinks and showers when they have finished using the Shower Facilities.
- The use of cameras, video cameras, mobile phones, and/or any other type of recording equipment is strictly prohibited within the Shower Facilities.
- No food or outside drink (other than non-breakable water bottles) is permitted within the Shower Facilities. Under no circumstances shall glass containers be permitted within the Shower Facilities.
- Solicitation of any kind will not be tolerated.
- Lockers are provided on a first-come, first-served basis and are to be used only while the User is using the Shower Facilities.
- All Users are required to provide their own lock when using the lockers.
- Any locks left on lockers or items left in the lockers when the User is not using the Shower Facilities may be removed and disposed of, at the sole discretion of the Manager and without notice or compensation to the User.
- Any items left unattended in the Shower Facilities may be turned into the Lost and Found, located in the Security Control room on the P2 Level of the Parkade. Items turned into Lost and Found will be kept for 90 days after which time they will be disposed of.
- The Building is smoke-free. Smoking and/or the use of electronic smoking devices is not permitted within the Shower Facilities and the Building.
- Please respect the respiratory sensitivities of others by not using heavily scented perfumes, colognes
  or other scented aerosols.
- Towels provided by the Owner for Users of the Shower Facilities may be placed in the designated drop off bins provided after use.
- Please immediately report any behavior or condition that is not in keeping with these Rules and Regulations to Security at (403) 265-4469.
- The Owner and Building manager are not be responsible for lost or stolen articles.
- All Users use the Shower Facilities at their own risk.

Although every attempt has been made to include all current rules, regulations and policies in this Schedule "A", the Owner and Building manager reserve the right to make changes to the rules and regulations as necessary. New rules and regulations will be deemed to have been communicated to the User upon being posted in the Shower Facilities.
